

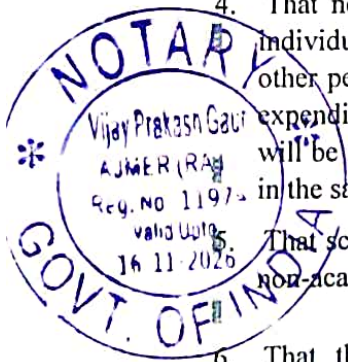

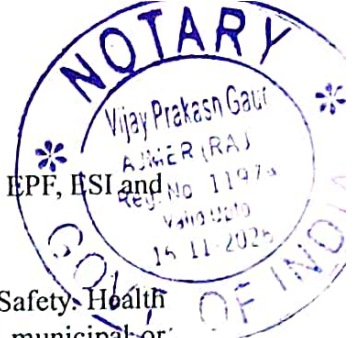
1. That St. Marys Higher Secondary School Educational Society, Ajmer , is a Registered Society under the Rajasthan Society Registration Act 1958 sec28.


